

# 12<sup>th</sup> National Lands Managers Gathering

## INDIGENOUS YOUTH REPRESENTATIVE

One Representative Per Regional Lands Association will be selected to attend NALMA's 12<sup>th</sup> National Gathering.

The Youth representative will be chosen based on the nomination form submission and supporting documents.

### Criteria and Selection Process. Youth Nominee must:

- Be between the ages of 18-30 at the time of the event
- Must be of Aboriginal descent (Inuit, Métis, First Nation)
- Have an interest/experience in, or is pursuing a career in land management, or other related field (i.e. environment, planning, natural resources, etc.)

### Entry Criteria. Nominator must:

- Submit the nomination form (page 2 of this document)
- Provide a nomination statement describing why you are nominating the Youth Representative for your Regional Lands Association
- A biography of the nominee

**Youth Representatives will be recognized for their achievements, and involvement in pursuing the field of land management or other related field. Travel sponsorship will be provided up to a maximum of \$3,000.**

Selected Youth Representatives will be mentored by their Nominator for the duration of the event, by participating in workshops and presentations.

Youth Representatives will participate in a short panel discussion on the final day of the Gathering to speak about their knowledge of land management, what they have learned at the Gathering, and what their goals are for the future.
